ADOPTION Terms and Conditions

All adoptions are subject to a site inspection to confirm a suitable home. After the site inspection, a two week trial period is offered to ensure a safe and suitable match of the cat with its new home.

Half the adoption fee must be paid prior to the start of the two week trial period. (Refundable if adoption does not go ahead). To complete the adoption process, remainder of payment and an Adoption Agreement and Transfer of Ownership must be completed.

Puppies and Kittens who are adopted before they are old enough to be desexed, are done so with the understanding you will have them desexed as soon as they are age appropriate.

An Adoption Application (this document) is an expression of an interest to adopt a cat. Completion of this document does not guarantee approval to adopt.

An Adoption Application (this document) may be referred to the CPRR team for consideration.

Decisions on Adoption Applications are based solely on an assessment of the applicant's capacity and commitment to provide a safe, loving and permanent home for the cat under consideration. With this in mind, the CPRR Assessment of Cat Adoption Applications is final.

Declaration and Signature

I acknowledge that a cat may live for 10 to 20 years and I am willing and able to meet the costs that are likely to be necessary to care for my cat including: ongoing costs of food, yearly vaccinations, regular flea and worm treatments over its lifetime. If my cat needs veterinary care I am willing and able to meet those costs.

I will welcome my cat as a member of my family and provide a secure, permanent and safe loving home. My cat will be an indoor and outdoor-enclosure cat only and I will not allow it to roam otherwise.

I have the physical and financial capacity to include a cat within my family and I will be able to maintain a good standard of care.

I will never re-home, sell or surrender my cat to a pound or animal shelter. I intend to provide a 'fur-ever' home, however should my circumstances change and I am unable to keep my cat, I am aware of my obligation to contact CPRR and return my cat to them.

I confirm I am over 18 years of age and if I am in rental accommodation, I have proven I have Strata and Landlord or Agent's permission to have a cat at the premises.
